Dear Messrs. Ahler and Cantelme:

As you know this firm represents the Checks and Balances Project ("C&BP") concerning its effort to obtain access to those text messages that are public records on Arizona Corporation Commissioner Bob Stump's smartphone that is currently in the possession of the Arizona Attorney General's Office. Almost five months have passed since C&BP's original public records request for certain text messages sent or received by Commissioner Stump between May 1, 2014 and March 11, 2015. Because the Commission has since produced a log of the texts messages sent and received on Commissioner Stump's smartphone, I thought it would be helpful for all involved to provide a list of the names and phone numbers of the text messages that may still be on Commissioner Stump's smartphone that C&BP wishes to examine and copy pursuant to its public records request:

C&BP does not seek any other text messages to and from any other phone numbers that may be contained on Commissioner Stump's phone. I am writing you both because at the moment the Attorney General's Office is the "custodian" of the public records sought by C&BP pursuant to A.R.S. §39-121.01(D). See Cox Ariz. Publ'ns, Inc. v. Collins, 175 Ariz. 11, 852 P.3d 1194 (1993) (where County Attorney had subpoenaed public records possessed by the Phoenix Police Department). While I expect that Commissioner Stump's smartphone will be returned to the Corporation Commission at some point, that does alter the custodian's duty to "promptly furnish" the public records requested by C&BP. Please let me know when C&BP may expect to be able to inspect and copy those text messages to which it first requested access almost five months ago.
