Dear Mr. Barr:

This letter is in response to Mr. Peterson's September 8, 2015 letter which follows up on an earlier public records request concerning various devices related to the Commission's Verizon accounts for Commissioner Stump. Mr. Peterson's letter also sets out a new public records request related to these matters, and expands the time frame for which records are sought.

In his requests Mr. Peterson states in relevant part:

- Thank you for the records you sent. However, we believe you may have overlooked some written communications, so we are asking you to take another look. There is no need for copies of any records already produced as a result of previous Checks and Balances Project records request.
- We would also like to amend our request to include any records between ANY representative of Verizon and ANY representative of the Arizona Corporation Commission from January 2, 2013, through TODAY regarding any device and/or account assigned to Bob Stump, including but not limited to 602-647-0433.

After your discussion last week with the Legal Division to try to clarify Mr. Peterson's requests, it appears it would be helpful for this response to identify the various telephone numbers that sometimes may appear to be associated with Commissioner Stump on Verizon's billing and email.


