NOVEMBER 2017-JANUARY 2018: SEITZ'S LEGISLATIVE OFFICE EXCHANGED MORE THAN 400 PHONE CALLS

From November 11, 2017 to January 4, 2018, Seitz's legislative office exchanged 403 phone calls using extensions 68258 and 62717. There were 82 phone calls with "unknown" telephone numbers, of which 70 appear to be internal numbers with the Ohio State House. The following table contains the number, owner, and call frequency associated with each extension, as identified in the public record. (Call Detail Record Search, as of January 4, 2018). There is no legal requirement to redact the last four digits of identified phone numbers, but we have done so as a courtesy.
